Purchase Contract

Which was conclueded between

Evelin Balássy owner of Blessed Borders Kennel, 3263 Domoszló, Malom út 0203/13. – furthermore the breeder – and from the other hand

Bep Boon, Lisgors 13, Mijnsheerenland 3271 XA – furthermore the buyer - with the conditions written below.

The object of purchase is the following puppy:

Breed: Border Collie

At the time of handing over the puppy is 9 weeks old. At the same time the breeder hands over the Vaccination Book and Passport of the puppy to the buyer.

The breeder will post FCI pedigree to the buyer as soon as it will be delivered to her (within 6 months).

The breeder states she is breeding in accordance with the international and national regulations of the FCI. Breeding dogs are complient with the FCI's official breed standard, as far as the breeder knows they are free of any kinds of diseases, are under regular veterinary supervision and are vaccinated as needed.

The puppy was vaccinated at the age of 6 and 8 weeks (these are written in his vaccination book) and dewormed at the age of 2, 4, 6 and 8 weeks. The owner is obliged to vaccinate the pup at the age of 10 and 12 weeks. The breeder cannot be held responsible for illness or problems arising if the vaccination scheme is not observed.

The breeder gives a guarantee for infectious diseases if determined within 10 days after handing over. After diagnosis (by a certified veterinarian!) the buyer is obliged to contact the breeder immediately. May the puppy die due to infectious disease during the period of guarantee the breeder will offer the buyer a new puppy of the same breed, gender and value.

The buyer agrees to have received a healthy puppy and acknowledges to have taken notice of the veterinarian recommendations.

The puppy doesn't show any visible signs of the following symptoms at hading over:

- vomiting
- diarrhea
- lack of appetite
- coughing
- lassitude
- festering eye fluid
- festering nose fluid
- nervous symptoms
- yellow discoloration of the mucous membrane

May the dog show any diseases or disorders, the buyer is obliged to contact the breeder immediately. Diagnosis by a certified veterinarian is required.

The buyer takes notice of that this puppy can never be sold to dealers. In case the buyer would like to sell the dog or place him at a third person she is obliged to inform the breeder. The breeder has the option of pre-emption.

The buyer is obliged to keep in contact with the breeder and inform the breeder of the dogs life, health (official health test results), show and/or working results, titles.

The breeder is entitled to visit the dog any time in the future. If the dog might be held not the right way (kepet in kennel fluently, her place is not cleaned, untidy, not right condition of the dog, injuries, lack of fresh water, under or overfed) or gets not the right treat (afraid of the owner, not well socialized) the breeder is entitled to buy her back at the original purchase price.

This contract was made in 2 copies, the breeder and buyer agreed to sign it.
